### **Decision details**

Sadhana Soni's practising certificate for 2024/2025 is subject to the following conditions:

1. Miss Soni may not be a manager or owner of any authorised body or an authorised nonSRA firm.
2. Miss Soni may not practise on her own account under regulation 10.2(a) or (b) of the SRA Authorisation of Individuals Regulations.
3. Miss Soni may not act as a compliance officer for legal practice (COLP) or compliance officer for finance and administration (COFA) for any authorised body, or Head of Legal Practice (HOLP) or Head of Finance and Administration (HOFA) in any authorised nonSRA firm.
4. Miss Soni does not hold or receive client money, or act as a signatory to any client or office account or have the power to authorise transfers from any client or office account.

In these conditions the terms are as defined in the SRA Glossary.



### **Reasons/basis**

The above conditions are necessary in the public interest. They are reasonable and proportionate having regard to the purposes set out in regulation 7 of the SRA Authorisation of Individuals Regulations, and the regulatory objectives and principles governing regulatory activities as contained in section 28 of the Legal Services Act 2007.

- Ms Soni has failed to comply with the SRA Principles (2019) and the SRA Accounts Rules (2019) which are rules made under sections 31 and 32 of the Solicitors Act 1974 – paragraph 1(1)( c) Schedule 1 Solicitors Act 1974.
