An <u>authorised body [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]_carrying on a practice [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#practice]_during any indemnity_period [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period]_beginning on or after 25 November 2019 must take out and maintain <u>qualifying insurance</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance]_under these rules with a <u>participating insurer</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer]</u>
- 3. In respect of its obligation under rule 2.1, an <u>authorised body</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]

must obtain a <u>policy [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#policy]</u> of <u>qualifying insurance</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance] prior to the expiry of the <u>policy period</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period], that provides cover incepting on and with effect from the expiry of the <u>policy period [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period]</u>.

- 4. 3. Notwithstanding rule 2.1 above, an <u>authorised body</u>

must take out and maintain professional indemnity insurance that



- provides adequate and appropriate cover in respect of current or past practice taking into account any alternative arrangements the body or its <u>clients [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> may make.
- 4. An <u>authorised body [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]</u> must ensure that its <u>clients</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#client] have the benefit of the indemnity insurance required under these rules and must not exclude or attempt to exclude liability below the minimum level of cover required under these rules.

Each <u>authorised body [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]</u>, and any <u>principal</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#principal] of such a body, must ensure that the <u>authorised body</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] complies with these rules.
- 5. The <u>SRA [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may require from an <u>authorised body</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] or any <u>principal [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#principal] in an <u>authorised body</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body], information and evidence it may reasonably require to satisfy itself that the body has complied with these rules.</u>

Rule 8: Use of information

- 8. Each <u>authorised body [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]</u> must notify the <u>SRA</u>

 [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] (or such <u>person [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> as the <u>SRA [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may notify to the <u>authorised body</u>
 [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] from time to time) and its <u>participating insurer</u>
 [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer] in writing as soon as reasonably practicable and in any event no later than five business days after the date on which:
 - 1. the <u>authorised body [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]</u> enters an <u>extended policy period [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period]</u>;
 - 2. the <u>authorised body [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]</u> has entered the <u>cessation period [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period]</u>; and

- 9. This rule is in addition to any obligations imposed on the <u>authorised</u> <u>body [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]</u> under the Provision of Services Regulations 2009.
- 10. If a <u>claimant [https://news.sra.org.uk/solicitors/standards-</u> regulations/glossary/#claimant] asserts a claim [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#claim] against an authorised body [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#authorised-body] or any person insured under that authorised body's [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#authorised-body] policy [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#policy], and the claim [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#claim] relates to any matter within the scope of cover of the MTC [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#MTC], the authorised body [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#authorised-body], and any person who is at the relevant time a principal [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#principal] in that authorised body [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] must, upon request by that <u>claimant</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#claimant], by any person insured under that authorised body's [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] policy [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#policy], or by any other person with a legitimate interest, provide the following details in relation to that authorised body's [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body] policy [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#policy]:
 - 1. the name of the <u>participating insurer</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#policy]; [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#policy];
 - 2. the <u>policy [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#policy]</u>number; and
 - 3. the address and contact details of the <u>participating insurer</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer] for the purpose of making a

For the purposes of the SA [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#SA] (including without limitation section 10 of that Act), any person who is in breach of any rule or part of any rule under the Solicitors' Indemnity Insurance Rules 2000 to 2010 or SRA Indemnity Insurance Rules 2011 to 2013 will be deemed, for so long as that person remains in breach, not to be complying with these rules.

SRA Minimum Terms and Conditions of Professional Indemnity Insurance

1. Scope of cover

1. Civil liability

Subject to the limits in clause 2, the insurance must indemnify each insured [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured] against civil liability to the extent that it arises from private legal practice [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#private-legal-practice] in connection with the insured firm's practice [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice], (including its prior practice [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#prior-practice] and (unless run-off cover is provided in accordance with clause 5.3) any successor practice [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice]) provided that a claim [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#claim] in respect of such liability:

- is first made against an <u>insured</u>

 [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-insurance]; Or
- 2. is made against an insured [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured] during or after the period of insurance [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-insurance] and arising from circumstances [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#circumstances] first notified to the insurer [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] during the period of insurance [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-insurance].

2. Defence costs

The insurance must also indemnify the <u>insured</u>
[<a href="https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured] against defence costs [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs] in relation to:

- 1. any <u>claim [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#claim]</u> referred to in clause 1.1; or
- 2. any <u>circumstances</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#circumstances] first notified to the <u>insurer</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] during the <u>period of insurance</u>; [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-insurance] or
- 3. any investigation or inquiry (save in respect of any disciplinary proceeding under the authority of the <u>SRA</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] and/or the <u>Tribunal [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#Tribunal]</u>) during or after the <u>period of</u>

3. The insured

For the purposes of the cover contemplated by clause 1.1, the insured [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] must include:

- 1. the <u>insured firm [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm]</u>; and
- 2. each service, administration, trustee or nominee <u>company</u>
 [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#company]
 owned as at the date of occurrence of relevant <u>circumstances</u>
 [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#circumstances] by the <u>insured firm</u>
 [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insuredfirm] and/or the <u>principals</u> [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#principal] of the <u>insured firm</u>

5. the estate or legal personal representative of any deceased or legally incapacitated <u>person</u>

The insurance must indemnify each insured [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured] against any amount paid or payable in accordance with the recommendation of the Office for Legal Complaints (including the Legal Ombudsman [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#Legal-Ombudsman] pursuant to section 137(2)(c) and section 137(4)(b) of the LSA [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#LSA1) or any other regulatory authority to the same extent as it indemnifies the insured [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured] against civil liability provided that the insurer [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insurer]_will have no liability in respect of any determination by the <u>Legal</u> Ombudsman [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#Legal-Ombudsman] pursuant to section 137(2)(b) of the LSA [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#LSA] to refund any fees paid to the insured [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured].

12. Withholding assets or entitlements

The insurance may require the <u>insured firm</u>
[https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] to account to the <u>insurer [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insurer]</u> for any asset or entitlement of any <u>person [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> who committed or condoned any dishonesty or fraudulent act or omission, provided that the <u>insured firm</u>
[https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] is legally entitled to withhold that asset or entitlement from that <u>person [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u>.

13. Premium

The premium may be calculated on such basis as the insurer

determines and the insured firm [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm]

history, categories of work performed by the insured firm [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm], numbers of principals
<a href="https://news.sra.org.uk/solicitors/standards-regulations/glossary/#principal] and employees [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#employees], revenue derived from the insured firm
practice [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice] and other risk factors determined by the insurer

8. Law and Jurisdiction

These MTC [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#MTC] and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with them or their subject matter or formation shall be governed by and construed in accordance with the law of England and Wales and subject to the jurisdiction of the courts of England and Wales.

- 2. no more than 25% of the <u>principals</u>

- 1. Clause 4.5 shall be deleted and replaced with the following:
 - 1. 4.5 No 'other insurance' provision
 - 2. The insurance must not provide that the liability of the insurer [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#insurer] is reduced or excluded by reason of the existence or availability of any other insurance other than as contemplated by clauses 6.1 or 6.12. For the avoidance of doubt, this requirement is not intended to affect any right of the insurer [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#insurer] to claim contribution from any other insurer [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#insurer] which is also liable to indemnify any insured [https://news.sra.org.uk/solicitors/standardsregulations/glossary/#insured].
- 2. Clause 4.8 shall be deleted and replaced with the following:
 - 1. 4.8 Resolution of disputes
 - 2. The insurance must provide that, if there is a dispute as to whether a practice [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#practice] is a successor-practice [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice] for the purposes of clauses 1.1, or 5.5, the insured [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured] and the insurer [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] will take all reasonable steps to resolve the dispute in conjunction with any related dispute

between any other party which has insurance complying with these MTC [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#MTC] and that party's insurer, and in conjunction with the provider of the Partial Home State Cover [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#Partial-Home-State-Cover].

3. Clause 4.12 shall be added:

1. **4.12** Period of insurance

- 2. The period of insurance must not expire prior to the date with effect on which the <u>Partial Home State Cover</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#Partial-Home-State-Cover] expires or is avoided.
- 4. The following clause shall be added:
 - 1. 6.12 Partial Home State Cover
 - The insurance may exclude any liability of the insurer to the extent that any such liability is covered under the terms of the <u>Partial Home State Cover</u> [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#Partial-Home-State-Cover] irrespective of whether recovery is actually made in respect of such liability.
- 3. In the event of an insured firm [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] which has the benefit of an exemption under paragraph 1 or paragraph 2 of this annex ceasing for whatever reason to enjoy that exemption but continuing to carry on a practice it shall be treated for all the purposes of these rules as though it had commenced the practice on the date when such exemption ceased.
- 4. Rule 5 (Insolvency of Participating Insurer) shall apply to an insured firm [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] which has the benefit of an exemption under paragraph 1 or paragraph 2 of this annex in like manner as though the insurance company or entity or fund providing professional indemnity cover under its home professional rules, on the basis of which exemption or partial exemption was granted, was a participating-insurer [<a href="https://news.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer].
- 5. In the case of an insured firm [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] which has the benefit of an exemption under paragraph 2 of this annex all the provisions of these rules shall apply to the additional professional indemnity insurance required under that paragraph to be taken out with a participating-insurer [https://news.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer].

indemnity period

means:

- i. in the SRA Indemnity Insurance Rules and the *MTC*, the period of one year starting on 1 September 2000, 2001 or 2002, the period of 13 calendar months starting on 1 September 2003, or the period of one year starting on 1 October in any subsequent calendar year
- ii. in the SRA Indemnity Fund Rules, the period of one year commencing on 1 September in any calendar year from 1987 to 2002 inclusive, the period of 13 calendar months commencing on 1 September 2003, and the period of one year commencing on 1 October in any subsequent calendar year.
